PROTECTED LANDS

ACR owns and stewards a system of nature preserves spanning 26 properties in Marin, Sonoma and Lake counties. These 5,000 acres are made up of tidal flats, marshlands, coastal prairie, oak woodlands, grassland, chaparral, mixed evergreen forests and redwood groves.

Bouverie Preserve

Oak woodland, evergreen forest and fire-adapted chaparral in Sonoma County's Valley of the Moon

Cypress Grove Research Center

Tidal wetlands and coastal uplands dotted along Tomales Bay near Marshall, Marin County

Martin Griffin Preserve

Wild lands and watershed overlooking the Bolinas Lagoon in Stinson Beach, Marin County

Modini Preserve

Rugged wilderness on the slopes of the Mayacamas mountains near Healdsburg, Sonoma County

RIGOROUS SCIENCE
